

COMPANY LEGALISATION IN DUBAI


- LLC MOA signed in front of the DED
- Template document provided limited amendments permitted
- Fees directly related to Share Capital
- Later amendment and additional GM powers may be required





FDI LAW – 100% FOREIGN OWNERSHIP


- Allows for up to 100% Foreign Ownership of LLC companies
- Not applicable to areas considered critical by UAE Government
- Qualifying criteria not yet defined





FREELANCER LICENCE


- Limited number of free zones offering this
- Permit does not include (or replace) residence visa
- Currently limited to media and education fields
- Not to be confused with TAJER licence in mainland Abu Dhabi





3000 BANK GUARANTEE vs WORKERS INSURANCE

- AED 3,000 bank guarantee
- AED 150 2 year insurance policy
- Refund process for existing bank guarantees paid







10 YEAR VISAS

- Investors
- Individuals with specialised talents

5 YEAR VISAS


- Investors
- Entrepreneurs







- New sponsorship policy for expats
 - Based on income over profession
 - To enhance family stability
 - Healthy balance between professional and personal life





TAWJEEH TRAINING


- Low level job titles
- Rights of the employee
- Rights of the employer
- Do's and don'ts





VISA TRANSFER APPLICATION

- Between DED licenced companies in Abu Dhabi and Dubai only – no labour quota required
- Cannot transfer from a free zone company or government entity to a DED company visa
- Transfers are possible between most free zones in the same Emirate
- Applicant must not have exited the country since cancellation





PART TIME CONTRACTS

- Only applicable to skilled workers
- No approval is required from the primary employer
- Non-compete clauses will be void








COMPANY BLOCKS FOR EXPIRED EMPLOYEE LABOUR CARDS OR WORK PERMITS

- Expired labour card
- Expired work permit
- Must renew or cancel
