Free Zones:

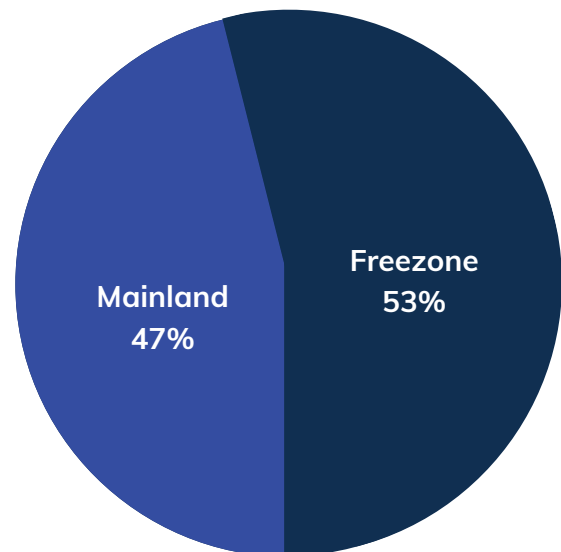
There are over 40 free zones in the UAE. Typically, free zones have been established to accommodate specific industries with technology and infrastructure in place to support certain business activities. For example, Dubai Airport Free Zone Authority (DAFZA) has a core focus on logistics and aviation sectors.

Mainland:

A mainland company is an onshore company licensed by Department of Economic Development (DED). Mainland companies can conduct business in a majority of industrial, commercial, trading, professional or tourism activities. Mainland companies are known for their less restrictive trading opportunities.

The government requires attestation of documentation to ensure the authenticity of personal documents, certificates and commercial documentation required for company set-up, residence visa and employment.



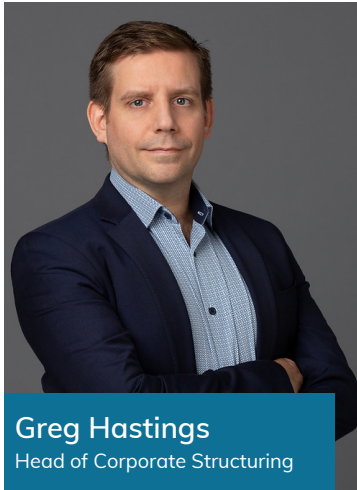
